We do hereby authorize and empower you to take and have the custody and management of the said John H. Robins and his estate, frugally and without waste or destruction, to improve the same in all things according to law, and when the said minor child shall have arrived at the full age required by law, or be otherwise sooner or legally discharged from said guardianship, or if he said minor shall die of you will pay and deliver to his legal representatives so much of his estate as may be found upon your account, after the same has been examined, audited and passed upon by the Court aforesaid.

In testimony whereof, I, Joshua Clayton Judge of the Probate Court, in and for the County aforesaid, have hereunto signed my name and affixed the seal of said Court this 6th day of July A. D. 1869

Know all Men by these Presents, that we, James M. Walcott as principal, and Jeremiah Jolley and Joseph W. Sykies as sureties, of the County of Miami and State of Kansas, are held and firmly bound unto the State of Kansas in the sum of Two Thousand dollars, good and lawful money of the United States, for which payment we bind ourselves firmly by these presents.

The condition of the above Bond is, that whereas the said James M. Walcott has been appointed by the Probate Court of Miami County, State of Kansas, Guardian of the person and estate of John H. Robins of the County of Miami and State of Kansas minor under the age of twenty-one years.

Now if the said James M. Walcott shall faithfully discharge his duties as said Guardian, according to law, or the order or decree of any Court having jurisdiction, then the above Bond to be void, otherwise to remain in full force.
