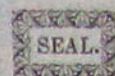

Irena Shunklin having arrived at the age of twenty-one years and <sup>being</sup> ~~su-~~ entitled to her distributive share of the residue of said estate, said guardian paid said share amounting to \$92 00 being one third of the money received by said guardian - see voucher No 4 -

Said guardian makes the same separate report as to the estate of Louiza Shunklin (now Louiza Ray) see voucher No 3.

Said guardian asks to be discharged from further responsibility on account of said wards - she having discharged her trust as guardian of their separate estates.)

She further reports that her said wards have resided with her since entering upon said trust until the marriage of Louiza, since which time the other two have resided with her; that she has boarded and clothed them during all of said time at her own expense, which would greatly exceed in amount the interest on the money in her hands and the rents which would accrue from their Real Estate; that she has kept no account of money expended in their behalf and can not do so now.
