ory and as it is appointed once for all men to die
and thatt pleased God to give me a small portion
of this worlds goods I do make and publish this my
last Will and testament in maner and forme
following that is to say I give and bequeath to
my beloved Wife Elizabeth Burger Two Fether Beds
and furniture two Milk Cows and all the profits
of the plantation that I now live on during her
lifetime or Widawhood also my Bay mare called
Trim and all the house hold furniture she now claims
during her life or Widawhood next I leave and bequeath
and give to my two sons John and James Burger
the quarter section of land John to have the west
end and James the east end of said land to
be Equally Divided by a north and south line

Through the middle to have and to hold the said land
after the death or widowhood of my wife I also give
to my daughter Elizabeth one dollar besides the property
she has received I also give to my daughter Mary one
hundred dollars besides the property she has already
received I also will and appoint that my Wagon
and horse gears my team horse my bay mare calves
shall be praised and sold at public auction
and three hundred and twenty dollars be given
for a quarter of Land next to be equally divid-
ed between my two sons John and James next
I give to my Daughter Hannah two hundred &
ten dollars I also appoint that all my farming
tools be given to my two sons John and James
equally divided I also will and appoint that my son
Daniel have all the money that will be left after the
above mentioned payments be legally made and that
it be applyed properly for his maintenance I also
appoint that my wife Elizabeth and my son John
be appointed Executors of this my last will and tes-
tament As Witness whereof I have hereunto set
my hand and seal this twenty fourth day of January
in the year of our Lord one thousand Eight
hundred eighteen
