Benjamin Patchiff produced in open Court the last Will
and Testament of John Swin of which probate was made by the exami-
-ation of Reuben Whittier one of the subscribing Witnesses, Ordered that the
said Will be recorded and that Benjamin Patchiff one of the
executors named therein file bond in the Clerk's office with a penalty
of One thousand Dollars with Samuel Stallcup as his security and
that he otherwise qualify to act as executor according to law

In the name of God Amen, I John Swin of the County
of Orange and State of Indiana being sick and weak in body but
of sound mind and disposing memory (for which I thank God) and calling to
mind the uncertainty of human life, and being desirous to dispose of all
such worldly estate as it has pleased God to bless me with
I give and bequeath the same in manner following that is to say
1st I give to my wife Mary Swin all my estate both real and personal for
and during the term of her natural life, except such as has heretofore been pro-
vided for, for our maintenance and support
2ndly After the death of my wife Mary Swin I give all my estate both
real and personal except such as heretofore been provided for for our support
and maintenance to my children equally to be divided among them and
to be enjoyed by them forever

and lastly I do hereby constitute and appoint my friends
Benjamin Patchiff and Elijah P. Wright executors of
this my last will and testament, hereby revoking all
other former wills or testaments by me heretofore made
in witness whereof I have heretofore set my hand and
affixed my seal this 26th day of October in the year

or widowhood, and if she shall at any time Marry then
I will and appoint My wife to have and to hold an
Equal part with my Children that is to say I will and
allow that my wife Mary and my Children, each and
all of them have an Equal part of my Estate to be Equally
Divided all my estate to be appraised and sold according to Law

I also appoint will and appoint My wife Mary
Cox Executrix of this my last will and testament, hereby
Revoking all former wills by me made as
