 equal shares a mong my three daughters Churry Esther
 and Sarah I order my Executors to see my Wagon
 and Brick Bands one case of Dracors and one oak
 Black waned table one pair of Dressors and all the
 remaining parte of my property not mentioned in this
 will Except the bees and furniture and divide the money
 Equal between my two daughters Esther and Sarah
 I also give to my two daughters Esther and Sarah each
 of them a Fether Bed and furniture I give to my son
 Stephen Wells one dollar I give to daughter Susannah
 Ray one dollar I give to my daughter Elizabeth
 one dollar I give to my son William Wells one dollar
 If my Executors find that my two sons Nathan & John
 are not sufficiently obedient and dutifull to their
 mother give them power to bind them to such mark
 as they may think proper and Lastly I nominate con-
 stitute and appoint Stephen Word and Levi Gifford
 Executors to this my last Will and testament

Be it remembered that on the the eighteenth
 day of February in the year of our Lord one thousand
 eight hundred and eighteen the last Will and testamen

of David Johnson deceased was produced to me
William Hoggatt clerk of the Orange Circuit Court
and proven by the oaths of George Gregory Joseph
Anderson and Beverly Gregory the Witnesses then to
subscribed and Jese Johnson the Executor therein named
performed on his part what was necessary to
obtain a Letter Testamentary before me
Nov 10th 1838

Which Will reads in the following words and figures
to wit

In the name of God amen I David Johnson
of the state of Indiana Orange County being weak in
Body but of sound and perfect mind and memory
considering the uncertainty of this mortal life do make
and publish this my last Will and Testament in
maner and forme following that is to say first I
give and bequeath to my beloved Wife Peggy
Johnson Ten Cows the value of one hundred and
twenty dollars also two head of Horses the value of
one hundred dollars and all the Stock of Hogs that
is in my possession except two sows and eight
yearling hogs and nine head of Sheek which is
all my Stock and all my house hold furniture
except one bed and furniture and all the
farming utensils and she also is to have the
use of the Lands and leased land that I now
have in my possession for the use of raising the
family this is to be hers and her own property
during her life or Widowhood I also give and
bequeath to my eldest son Joseph Johnson seventy
five dollars in money in one year after my decease
and also five head of Hogs one sow and four shotes
I do also give and bequeath to my second son Jese
Johnson one horse the value of seventy dollars
also four head of hogs one sow and four shotes
and also to the aforementioned Joseph Johnson and Jese
Johnson each of them to have one new saddle a
pice and each of them to have a Rifle gun
at the price of eighteen dollars each I do also give
two and bequeath to my eldest Daughter Sarah
Johnson one cow and calf and also one bed and
furniture and also a new saddle and thirty one
dollars in money I do also give and bequeath David
Johnson my third son a full and equal parte
with the aforementioned Joseph & Jese Johnson when
he may be of full age of twenty one years

I do also give and bequeath to my second Daughter
Lydia when she may be of full age of eighteen years
an equal parte with my son Joseph and Jese Johnson
I do also give and bequeath to my fourth son Ephraim Wese
Johnson an equal parte with Joseph Johnson and Jese
Johnson when he may be of full age of Twenty one years if there
is as much surplus property in the hands of the Executors
when he comes to the age of not he shall wait for the same
untill the land is sold then he is out of that money to be
made equal with the four mentioned sons

I do give and bequeath to my third daughter Ruthy
Johnson an equal parte of my estate with Joseph and
Jese Johnson when she may be of full age of eighteen
years if there is somech surplus property in the hands
of the executors if not when the land is sold she shall
be made equal with the four mentioned sons

8th I do also give and bequeath to my to my fifth son
Eli Burket Johnson an equal parte of my estate
with my four mentioned sons Joseph and Jese Johnson
when he may be of full age of Twenty one years if there
is somech surplus property in possession of the Executor
when of such age if not when the land is sold he shall
be made equal with the four named sons

I do also give and bequeath to my fourth Daughter Mary
Johnson an equal parte with my two sons Joseph & Jese
Johnson when she may be of full age of Eighteen years if
there be somech surplus property in the hands of the Executor
when she is of such age if not when the land is sold
she is to be made equal with them out of my estate

I do also give and bequeath unto my sixth son Thomas Nelson
Johnson an equal parte of my estate with my two sons Joseph
and Jese Johnson when he may be of full age of Twenty one
years if there be somech surplus property in the hands of the
Executor when is of such age if not when the land is
sold he shall be his Equal share with the four mentioned
sons And lastly as to all the rest of and remainder of my
property if any when the youngest child Thomas Nelson
Johnson comes of full age of twenty one years shall be
equally divided amongst the four named Legates to wit
Joseph and Jese and Sarah and David and Lydia
Eli Burket and Matilda and Thomas Nelson Ruthy
and further more let it be understood Jese Johnson my
son when he may arrive at full age of twenty one he shall
so long as he remains to take care of his Mother and her property
and will tend or cultivate the cleared land he shall
have the third of all that is raised of said land
And also let it be known that the land on which

14 That not be sold until the youngest child comes
to full age of Twenty one years
And let it be further known that so much of the income
of property left in the hands of the widow as can
be conveniently spent shall be the younger children
to teach them a reading and writing

15 And also when the land is sold Ruthy Johnson my true
Daughter shall have fifty dollars more than her parts
of my estate but knowen that I hereby appoint Jese
Johnson my second son my legall and lawfull
Executor of all this my last will and testament
hereby revoking all others formerly made by me
In witness whereof I have hereunto set my hand
and seal this 2^d day of June in the year of
our Lord one thousand eight hundred seventeen
signed sealed published David Johnson Seal
and delivered by the a
bove named David

Johnson to be his last Will
and Testament in the presence

the quarter section of land John to have the west
end and James the east end of said land to
be Equally Divided by a north and south line
