I William Mc Donald of Orange County & State of Indiana, being sound of mind and memory but calling to mind the mortality of my body knowing that it is appointed for all men to once to die as it has pleased God to bless me with some property of this life it is my will the same be distributed in the following manner (viz) First I recommend my soul to God who give it and my body to the Earth to be buried in a decent manner at the will of my Executors here after mentioned. 2nd That all my Just debts together with my funeral expences be paid out of my Estate. 3rd I do give and bequath to my grand William M Hobson the North west quarter of the North west quarter of section fifteen in Township one south of Range one west, the south east quarter of the North west quarter of the same section also the North East quarter of the North west quarter of the same section and also the south west quarter of the same section. 4th I do give and bequath to my Grand daughter Rachel Hobson the south west quarter of the North East quarter of section fifteen Town one south of Range one west, also the North East quarter of the North East of the same section, and also the south west of the North East of section sixteen Township one south of Range one west - also the south west of the North East quarter of the same section. 5th and I do give and bequath to my grand son Hiram Hobson the North East quarter of the North west quarter of section fifteen Township one south of Range two west also the North East q^r of the North East quarter of the same section also the North East of the south west quarter of the same section. 6th and further for the better maintainance and for his dutiful obedience to me I do give and bequath to my grand son William Hobson the south west q^r of the south East q^r of section 9. in Township one south of Range one west. 7th And further I do give and bequath to my grand son William Hobson Lots No. twenty one and twenty two in the Town of Hewton Stewart Orange Co. 8th and I further give and bequath to my grand son Hiram Hobson Lots No. twenty four and all that part of Lots No. 32 and thirty three not used in the burying ground in the Town of Hewton Stewart, also Lot No. twenty three in saide Town aforesaid. 9th And I further give and bequath my grand children William Hobson, Rachel Hobson and Hiram Hobson my money rights Credits and effects which may belong to me at my decease to be equally divided - I also hereby constitute and appoint Eli Allen and Clement Mc Donald my Executors to this my last will and testament Revoking all others here before made by me. In witness whereof I have hereunto set my hand and seal this 11th day of April in the year of our Lord one thousand eight hundred fifty one - published pronounced and delivered by the saide William Mc Donald to be his last will and testament in presence of
