It is my will that all my just debts be paid And first I give and bequeath unto my beloved wife Agnes a tract of Land where I now live including the house and plantation and I also give unto my beloved wife all my stock and farming utensils also one bed and bedding and such part of the kitchen furniture as shall not hereafter be otherwise disposed of during her natural life

It is also my Will that my son Tildan have all my stock farming utensils bed furniture &c that is all the portion of my wife at her decease I also will and bequeath unto my daughter Ruth one cow and bul five head of sheep Two Feather beds and furniture one beeran six plates one Iron Pot I also give unto my son Lewis the Tract of Land I now live on containing Eighty Eight Acres including the above mentioned part at the decease of my wife I give unto my son Joseph one dollar to my son Stephen I give one dollar to Charles

Baughman one dollar to John Baughman one dollar to Burrel Graham I give one dollar to Eli Morris one dollar James Atkinson one dollar to William Trublow one dollar and to Daniel Lambelin I give one dollar

And lastly I ordain constitute and appoint my truly and well beloved friends Shadrach Ditto and Tildan Thomas joint Executors of this my last Will and Testament utterly disallowing and revoking all others wills by me made or intended ratifying and confirming this and no other to be my last Will and Testament

 my Executor) The premises wherewith I now live with  
 all its appertinances containing fifty acres of land  
 more or less lying and being in the County and State  
 aforesaid in Town three north Range one East  
 Section thirty in the district of lands offered for  
 sale at Jeffersonville it being part of a Tract of  
 Land that Adam Hostetter bought and purchased as  
 per deed in my name together with all the Home  
 hold and kitchen furniture and every other species  
 of Property that is mine to have and to hold
