ing that it is appointed for all men one to die

do make and declare this my last Will and Testament

That is to say principally and first and of all I give
and bequeath my soul into the hands of Almighty God
that gave it and my body I bequeath to the Earth in
silent Christian Burial at the discretion of my Executors

John B Mayer Joseph Crawford and To Single nothing
doubting but at the General Resurrection I shall receive
the same again by the mighty power of God that gave it

And as touching such worldly Estate wherewith
It has pleased God to bless in this life I give devise

and dispose of the same in the following manner
and form First I give to Sarah an Perrot the Daugh-
ter of Susannah Perrot The N & W q^r of Section

N^o 30 Range One E and Township 3 N containing
one hundred and fifty six acres more or less and for
her to be liberally Educated from the Rent and surplus

that shall be made on the place; If she should not live
