## Help Index The 1940 Census

The National Archives will be releasing the digital images of the 1940 census on Monday, April 2 at 9 am Eastern on a special website - <http://1940census.archives.gov/>

Archives.com, FamilySearch International and FindMyPast.com are heading a [project](#) to coordinate the efforts of the genealogy community to create a free online index of the 1940 census. The Indiana Genealogical Society is coordinating efforts to index the Indiana portion of the 1940 census. Here's how you can help:

1. Go to <http://the1940census.com/society/>
2. Under "Society Members," click the red "Get Started" button. (This will prompt you to download the FamilySearch Indexing software. Download it and install

- it on your computer.)
3. When you launch the indexing software, you will be asked to "Register for a New Account" or "Sign In." (If you already have a FamilySearch account that you use for indexing or for access to record images, you can just sign in.)
  4. The "Register for a New Account" button will take you to the FamilySearch website to set up your account. Fill in all the information.
  5. Join the IGS group by e-mailing your username to Vice President Tina Lyons at [genwishlist@gmail.com](mailto:genwishlist@gmail.com). Alternatively, you might see a drop down box when you register that will allow you to select IGS as your society.
  6. Tell the 1940 U.S. Census Project that you want to help by entering your e-mail, name and favorite state in the form that's on the front page of <http://the1940census.com>. This will let them know how many people are available to index and keep you informed about the project through e-mail.

The indexing will begin as soon as the digital images are released on April 2nd - in the meantime, you can practice by working on two test batches that FamilySearch has created.

## Fort Wayne Conference Nears

There is just over a month left to register for the Indiana Genealogical Society's annual [Conference](#) on Saturday, April 28, 2012 at the [Allen County Public Library](#) in Fort Wayne. With Debbie Mieszala as our featured speaker, it promises to be a great event. Her sessions will be:

--Lessons From A Snoop: Collaterals and Associates -  
Crucial information on direct ancestors is often found by nosing into

the lives of collateral relatives, associates, and neighbors. Case studies present examples of invaluable finds.

--Digging Through Documents Word by Word - Proper scrutiny of each piece of information in a document is essential to understanding that item's evidentiary value. Studying every word's meaning and context ensures that evidence has been properly analyzed and comprehended.

--Patently Unique: Locating Patent Records, Online and Off - Was your ancestor an inventor? Learn how to locate patent records quickly and easily. Patents offer glimpses of creative genius and add interesting stories to family research.

--Bringing Our Soldiers Home - Thousands of lost soldiers and airmen from past wars were never recovered. Some were missing in action, killed in action, or prisoners of war. Learn about the project that aims to bring them home, and how genealogy is aiding in that effort.

There will also be sessions offered on Ancestry.com expert tips, FamilySearch news, and writing a book using Family Tree Maker and Microsoft Word. In between sessions, you can browse the vendor area, enjoy the hospitality provided by the [Allen County Genealogical Society of Indiana](#), or get in a little research time at the [Genealogy Center](#).

## Legislative Roundup

The [Indiana General Assembly](#) wrapped up this year's session in the early hours of Saturday, March 10. Here is the status of several bills that were under consideration:

--[House Bill 1015](#) was passed and awaits the governor's signature. It deals with the issue of access to a cemetery that is on private land. It states that the landowner must give access to the cemetery to the family members of the deceased at least 3 days out of the year (with the dates of access to be worked out between the land owner and the family members). In return for this access, the landowner is absolved of liability for any injuries that may result to the family members from their access.

--[House Bill 1034](#) was passed and signed into law. Effective July 1st, it expands the cemeteries that county cemetery commissions can have jurisdiction over to include those that were established before 1875 or that have a Civil War veteran buried in them. Previously, county cemetery commissions' jurisdiction was limited to cemeteries that were established before 1850, had an "American war" veteran buried in them or showed signs of neglect.

--[House Bill 1093](#) (and its similar versions offered in the Senate) appears to have been shelved. It would have given a court the option to impose a fine (\$100 for the first violation; \$500 for subsequent violations) on a government agency and/or its officials if the state's [Public Access Counselor](#) determines that a violation of the state's open records law or open door law has occurred.

--[House Bill 1207](#), which included provisions to change the state's civil service system, including employees of the Indiana State Library, the Indiana Historical Bureau and the position of State Archivist, was engrossed into [House Bill 1283](#), which gained attention because it designated an [official state rifle](#) of Indiana. House Bill 1283 was passed and awaits the governor's signature.

Our [Indiana Marriage Indexing Project \(1811-1959\)](#), done in partnership with FamilySearch, continues to move forward. Entries from LaGrange County, Lake County and Lawrence County have been added, bringing the number of Indiana counties included in the

index to 38. FamilySearch estimates that the project is 58% complete.

Indexers are currently working on records from Jefferson County, Jennings County, Kosciusko County, Martin County, Morgan County and Randolph County. Your help is welcome - just sign up with [FamilySearch Indexing](#), go to their Partner Projects page and download a batch from our project.

## County Roundup

News items and newly-found resources from around the state:

ALLEN COUNTY:

--The [Chief Richardville House](#) in Fort Wayne has been [designated](#) a National Historic Landmark by the National Park Service. The building dates back to 1827 and was the site of a treaty signed between the federal government and the Miami tribe, of which Jean Baptiste de Richardville was Chief.

JACKSON COUNTY:

--The Jackson County Courthouse has been [added](#) to the National Register of Historic Places. The courthouse dates back to 1873.

--The Carr Township school has been [added](#) to the National Register of Historic Places. The school dates back to 1857.

JOHNSON COUNTY:

--Smiley Cemetery in Franklin was [vandalized](#). Brad Manzenberger of Stone Revival Historical Preservation has posted a [Facebook photo album](#) of the damage.

--The [Johnson County Museum](#) in Franklin has a great collection of records for your Johnson County research. In a [YouTube video](#), Linda Talley gives a tour of some of their resources, including the marriage books and probate packets.

KNOX COUNTY:

--[Grouseland](#), the home built in Vincennes in 1803 for territorial governor William Henry Harrison, has received a [grant](#) from Indiana Landmarks to help fix part of its structure. The home is a National Historic Landmark and is also on the National Register of Historic Places.

LAKE COUNTY:

--The project to restore the tombstones of Civil War veterans in northwest Indiana continues, with students in Crown Point seeing the tombstone of Colonel John Wheeler (See [news item](#)).

--Local officials are moving forward with plans to [demolish](#) the old

[Lowell grade school](#), which dates back to 1896.

--The Lake County Recorder's office is implementing an online service where users can purchase digital copies of the office's records, including land records (See [news item](#)).

#### MARION COUNTY:

--Condolences to the friends and family of Jane Eaglesfield Darlington. A Certified Genealogical Records Specialist (CGRS), she authored numerous genealogy resources for those with Indianapolis/Marion County ancestors.

#### MONROE COUNTY:

--The [Monroe County History Center](#) in Bloomington is looking to hire a [Education and Volunteer Coordinator](#) to give educational programs and tours.

#### SHELBY COUNTY:

--The [Shelbyville-Shelby County Public Library](#) will be shortening its name to just the Shelby County Public Library, and will also be moving to a new website in the next few weeks. (See [news article](#))

#### TIPPECANOE COUNTY:

--The [Tippecanoe County Historical Association](#) in Lafayette is busy computerizing its inventory of its collection of genealogical and historical materials (See [news article](#)).

## FamilySearch Increases Microfilm Rental Cost

Effective 15 February, FamilySearch increased the cost to rent its microfilm to \$7.50 per roll. This microfilm is loaned to the public via its Family History Centers and more recently, libraries that have been certified as Family History Affiliates. As noted in [Dick Eastman's newsletter](#), the cost of the raw material used to make the microfilm is skyrocketing, and finding the raw material is becoming more difficult.

## National Archives - Chicago Branch Closed For Repairs

The [National Archives - Great Lakes Branch](#) in Chicago closed its textual and microfilm research rooms at the end of February to effect repairs to the building.
