**DECLARATION TO BE MADE BY MAN ON ATTESTATION.**

I, Paul Rhei Cook, do solemnly declare that the above are answers made by me to the above questions and that they are true, and that I am willing to fulfil the engagements by me now made, and I hereby engage and agree to serve in the Canadian Over-Sea Expeditionary Force, and to be attached to any arm of the service therein, for the term of one year, or during the war now existing between Great Britain and Germany should that war last longer than one year, and for six months after the termination of that war provided His Majesty should so long require my services, or until legally discharged.

Date 16th June 1917. Paul Rhei Cook (Signature of Recruit)

**OATH TO BE TAKEN BY MAN ON ATTESTATION.**

I, Paul Rhei Cook, do make Oath, that I will be faithful and bear true Allegiance to His Majesty King George the Fifth, His Heirs and Successors, and that I will as in duty bound honestly and faithfully defend His Majesty, His Heirs and Successors, in Person, Crown and Dignity, against all enemies, and will observe and obey all orders of His Majesty, His Heirs and Successors, and of all the Generals and Officers set over me. So help me God.

**CERTIFICATE OF MAGISTRATE.**

The Recruit above-named was cautioned by me that if he made any false answer to any of the above questions he would be liable to be punished as provided in the Army Act.

The above questions were then read to the Recruit in my presence.

I have taken care that he understands each question, and that his answer to each question has been duly entered as replied to, and the said Recruit has made and signed the declaration set forth: the oath before me, at Liberty Mills, Ind. this 16th day of June 1917.

digitizing their collection of Canadian Expeditionary Force (CEF) service records. The significance of the CEF was that many Americans also enlisted in it, spurred by their English, Scottish or Irish roots and the opportunity to participate in the Allied war effort before the United States became officially involved in April 1917.

If you have access to a subscription for Ancestry.com, you'll note that they have a database, [Canada, WWI CEF Attestation Papers, 1914-1918](#), which is an index of enrollments in the CEF - called "attestations". Ancestry.com's index shows 245 Canadian Expeditionary Force soldiers who listed Indiana as their residence at the time of enlistment; now that Library and Archives Canada has finished digitizing the enrollment papers, you can [view](#) them yourself for free.

NOTE: When you click on a search result in the Library and Archives Canada's database, it will show only a thumbnail image of the attestation paper. To view the entire service record file for that soldier, be sure to click on the link "digitized service file - PDF format" that's next to the thumbnail image.

Like the World War I draft registration cards that were used in the United States, the CEF enrollment paper contains some biographical information as well as physical details. In the example shown here, Paul Rhei Cook is a telegraph operator in Liberty

Mills, Indiana, born 11 August 1887, and names his mother Alice as his next of kin. On the back of this page (not shown), it describes him as being 5 foot 7 1/2 inches tall, having blue eyes and dark brown hair, and belonging to the United Brethren Church.

Cook's service record file is a 48-page PDF that includes many more details, including that he was treated for a gunshot wound to the nose, was hospitalized twice for tonsillitis and even describes what teeth he was missing and/or had fillings for when he was discharged in 1919.

## IGS adds 30 free databases from scanning kits

We recently added 30 free databases that were contributed by recipients of our [Indiana Genealogy Digitization Project](#) - a project to give portable scanning kits worth \$500 to qualified non-profit groups in Indiana. In recognition of this project, the Federation of Genealogical Societies presented the Indiana Genealogical Society with its Outstanding Society Technical Award at its recent conference in Fort Wayne.

## County Roundup

Here are some genealogy-related news items from around the state.

NOTE: Items on other websites often change or are removed without notice - we apologize if you encounter a link that no longer works.

#### **ALLEN COUNTY:**

The remains of a Navy sailor from Fort Wayne who died during the attack on Pearl Harbor have finally been [identified](#) and returned to his family. Arthur Glenn was among those killed on the USS Oklahoma on December 7, 1941 - it was his 43rd birthday.



#### **DELAWARE COUNTY:**

- Construction crews working on a bridge in Albany [discovered](#) a list of men who had worked on the bridge when it was built in 1939. The list was encased in one of the bridge's pillars.
- The Delaware County Historical Society recently received a \$10,000 [grant](#) to help inventory its collections. The group is based in Muncie.

#### **FRANKLIN COUNTY:**

A Batesville newspaper has an [article](#) about the history of Franklin County's various photographers.

#### **JENNINGS COUNTY:**

A military dog tag belonging to a missing Korean War soldier from Vernon was recently [found](#) and returned to his family. Charles H. McDaniel was a Master Sergeant in the Army when he went missing in 1950.

#### **SHELBY COUNTY:**

Several tombstones at the Davis-Bennett Cemetery in Morristown were recently [vandalized](#) (see photo above). The cemetery dates back to the early 1800's and among the graves that were vandalized were a Revolutionary War veteran and his wife. Four juveniles were [arrested](#) in connection with the vandalism.

#### **ST. JOSEPH COUNTY:**

The Michiana Jewish Historical Society recently [received](#) a \$21,000 grant from the Indiana Historical Society to improve access to its archives. The group is based in South Bend.


## Legal terms explained: Curtilage

In our July 2018 e-mail, we explained *messuage*, which is a term used in old deed records - it's the buyer's right to the dwelling house and any other outbuildings associated with it. A related term used in old deed records is *curtilage* - it's the buyer's right to the land that immediately surrounds the dwelling house. Curtilage has also been recognized in court decisions as being an area that is protected by the 4th Amendment from unreasonable searches and seizures.

## RESEARCH TIP: Enumerations of Indiana's schoolchildren

In 1832, Indiana passed its first law calling for the annual enumerations of children who were of school age (defined as being between the ages of 5 and 21). Trustees for each Congressional Township were to make a note of how many children each resident had, grouping the children as being: 1) under age 5; 2) between age 5 and 14 and 3) between age 14 and 21.

The earliest enumerations did not have to include the child's name or age, although some enumerators did so anyway. Another law passed in 1852 established common schools (which were for grades 1 through 8) and that the trustees of each civil township would be responsible for an annual enumeration of children between the ages of 7 and 17, grouped as being: 1) between age 7 and 12 and 2) between age 12 and 17.

Indiana did not make attending school mandatory until 1897, when it passed a law making it compulsory for children between the ages of 8 and 14 to attend school. To help enforce this law, the annual enumerations were to include more details about the children, including their date of birth and place of birth, as well as a signature from their parent or guardian affirming their children's status.

### WHERE TO FIND THE RECORDS:

- County Auditor's office - The township trustee was to send the completed enumeration to them.
- Indiana State Archives or Indiana State Library - Back when there were was a superintendent of

schools for each county (before school corporations were formed), they may have sent their enumerations to the State Superintendent of Public Instruction. The records of that office are found at the State Archives and/or the State Library.

- Libraries and other local repositories - The enumeration of a Congressional Township in 1845 Guilford Township, Hendricks County (pictured above) is in the collection of the Plainfield-Guilford Township Public Library.
- [Internet Archive](#) - Among the books they have digitized so far is a transcription of the 1916 enumeration for [Spice Valley Township, Lawrence County](#)
