

## IGS conference in Fort Wayne with DNA expert

Registration is open for the Indiana Genealogical Society's annual **conference**, to be held on **Saturday**, **April 13**, **2019** in the Genealogy Center of the Allen County Public Library in Fort Wayne. Blaine Bettinger, author of *The Family Tree Guide to DNA Testing and Genetic Genealogy*, and "The Genetic Genealogist" blog, will be the featured speaker.

Bettinger will present sessions on:

#### **UPDATE: Indiana's World War I records**

In our <u>June 2018</u> e-mail, we told you about separate projects by the Indiana State Archives and FamilySearch to index Indiana's collection of World War I enrollment cards. FamilySearch has now begun to put their index <u>online</u>, with 134,000 entries so far. FamilySearch's index can be freely accessed, but their digital images of these enrollment cards are <u>restricted</u> - you must be at a computer in a Family History Center or FamilySearch Affiliate Library in order to view them.

## **County Roundup**

Here are some genealogy-related news items from around the state.

NOTE: Items on other websites often change or are removed without notice - we apologize if you encounter a link that no longer works.

#### **DUBOIS COUNTY:**

The Allen County Public Library recently added digital images of an <u>1896 history and souvenir of Dubois County</u> to their <u>website</u>.

#### **HAMILTON COUNTY:**

A woman who was born in a Noblesville hospital more than 40 years ago recently learned the identity of her biological mother, thanks to Indiana's unsealing of its adoption records from 1941 through 1994.

### **HUNTINGTON COUNTY:**

The Allen County Public Library recently added digital images of a <u>1949-1950 public schools directory</u> of Huntington County to their <u>website</u>.

### **JOHNSON COUNTY:**

The Veterans of Foreign Wars' post in Whiteland recently raised money to <u>purchase a tombstone</u> for World War II veteran Bill Tuley, who died in 2002. His grave at Forest Lawn Memory Gardens in Greenwood had been unmarked for 16 years.

#### **MARION COUNTY:**

- --Two history professors at Indiana University-Purdue University Indianapolis recently received a **\$150,000 grant** from the National Endowment for the Humanities to expand their smartphone app and website about Indiana history. The app and website, called "Discover Indiana," features facts and virtual tours of historical sites all over Indiana.
- --The remains of Marvin E. Dickson, an Indianapolis soldier who died in Germany in 1944, have finally been <u>identified</u> thanks to DNA analysis.
- --Workers remodeling a house in Indianapolis recently came across a **bottle of beer** made by the Home Brewing Co. which went out of business in the 1920's thanks to Prohibition.

### **PERRY COUNTY:**

A 65-year-old Tell City man recently <u>learned the identity</u> of his biological mother, thanks to Indiana's unsealing of its adoption records from 1941 through 1994. The state's Department of Health is reporting they now have a **5-month backlog** of requests for adoption records.

#### **RUSH COUNTY:**

Hopewell Cemetery in Richland was recently the victim of <u>vandalism</u>, including a fire that was intentionally set. One family that has relatives buried in the cemetery is offering a reward for information.

#### **TIPPECANOE COUNTY:**

An 1841 map of Lafayette that was discovered in a pawn shop last year turned out to have been mistakenly <u>removed</u> from an area library.

### IGS adds 16 new databases for members

We now have **2,263** total databases for members, including at least 10 databases for each of the 92 counties in Indiana.

Here are all the premium databases (accessible only to IGS members) that we've added recently:

#### College Records:

- Central Normal College, Danville autographs of students (1883).
- DePauw University, Greencastle graduates (1957).
- Indiana Institute of Technology, Fort Wayne directory of alumni of Indiana Technical College (1955). NOTE: Indiana Technical College later changed its name to Indiana Institute of Technology.
- University of Evansville, Evansville directories of students & faculty at Evansville College (1955). NOTE: Evansville College later changed its name to University of Evansville.

## **County Records:**

- Elkhart County Griner School students (1904). NOTE: Griner School was District #5 in Middlebury Township.
- Huntington County Huntington High School graduates & teachers (1954).
- Jay County plat book (1949).
- Kosciusko County plat book (1963).
- Tipton County Windfall High School students & teachers (1922).
- Union County Short High School teachers (1954); students grades 1-12 in Short schools (1954).
- Wayne County Hagerstown High School students & teachers (1949).

# Legal terms explained: Dr

If you see the notation "Dr" in court records, don't assume it is an abbreviation for "doctor". In the 1800's, "Dr" was more likely to be used as an abbreviation for "debtor" - someone who owed money. This was especially common in foreclosure and bankruptcy cases.



# **RESEARCH TIP: Indiana's prisons**

In 1822, Indiana opened its first state prison, in Jeffersonville (Clark County). Known as the Indiana State Prison, it accepted prisoners from all over the state.

In 1860, due to growing population, the state opened a second state prison, in Michigan City (LaPorte County). At that point, the Jeffersonville location became known as Indiana State Prison South, and would only accept prisoners from the counties in the southern half of the state, while the Michigan City location became known as Indiana State Prison North, and would only accept prisoners from the counties in the northern half of the state.

When the Jeffersonville location first opened, it housed both male and female prisoners. In 1873, the state opened a separate prison for women in Indianapolis (Marion County). It still exists today.

In 1897, the Jeffersonville location changed from being a state prison to a reformatory for male offenders ages 16 to 30. Prisoners who were over the age of 30 were transferred to the Michigan City

location. At that point, Michigan City changed its name to the Indiana State Prison. It still exists today.

In 1915, the state opened the Indiana State Farm in Putnamville (Putnam County) as a minimum security work camp for men who had been convicted of a misdemeanor. In 1977, the Putnamville location was changed to medium security for males who had been convicted of a felony and its name was changed to the Putnamville Correctional Facility. It still exists today.

In 1867, the House of Refuge for Juvenile Offenders opened in Plainfield (Hendricks County). In 1883, its name was changed to the Indiana Reform School for Boys, and in 1903 to the Indiana Boys' School. The Indiana Boys' School closed in 2005. The Plainfield location is now known as the Heritage Trails Correctional Facility.

In 1873, the state opened a Reform School for Girls, as part of the Women's Prison. In 1899, its name was changed to the Indiana Industrial School for Girls and in 1907, its name was changed to the Indiana Girls' School and it moved to its own location, in Clermont (Marion County). The Indiana Girls' School closed in 2009.
