Eligibility:

The nominee does not need to be a member of IGS but must receive a proper nomination and meet all the specific requirements.

Nomination:

The nomination for this award must be made by at least two current IGS members using the proper nomination form and providing all required documentation. The nomination form must have an additional document attached that explains in detail:

- What the nominee has accomplished over ten years or longer
- What organization has been the recipient of the nominee's service
- If a part of this service was compiling books, please provide exact titles, dates of publication, and other pertinent information.

Nomination Deadline:

Review:

The Awards Committee shall review all nominations and select a recipient. The Committee then submits the recommended recipient(s) to the IGS Board for approval. The Indiana Genealogical Society reserves the right to not bestow an award, grant, or scholarship in a particular year.
